
# **SCHOOL ANTHEM**

# President's Opening Address

WE CAN NOT AFFORD TO SHY AWAY FROM BEING A LEADING ADVOCACY GROUP IN THE COUNTRY

- 1. The Chairman and Members of the Board of Trustees Federal Government College Ilorin, Old Students Association (FGCIOSA), Members of the National Executive Committee of FGCIOSA and All Distinguished Members of our Great Association. Before I present my address on the occasion of the 2023 AGM taking place at Ilorin on 18 February 2023. I herebywill request that we observe one minute of silence in honour of our departed colleagues who have passed on to the great beyond. May their gentle Souls Rest in Perfect Peace Amen.
- 2. It is with all humility and gratitude to Almighty God that I present this report on this occasion marking the 12<sup>th</sup> AGM of our association being hosted by the Ilorin Chapter in the ancient city of Ilorin. I personally welcome you all to this AGM. This AGM is unique in the sense that it is taking place along with other activities to mark the 50<sup>th</sup> anniversary of our Alma Mater. Also, I thank those of you linking up on the zoom platform despite its constraints and for considering sparing your time to participate in this AGM.
- 3. It will be recalled that the National Executive Committee of this association was inaugurated on 14 March 2020 and barely two weeks into its tenure, the nation and indeed the whole world experienced a lockdown of severe magnitude as a result of the spike inCOVID -19 infections worldwide. This pandemic delivered a serious setback in the association activities. This development presented serious challenges to our association at all levels especially at the Chapters and Set levels. These levels were more engaged with offering welfare support to their members through self and collective contributions to assist the less

privileged members of the association. I will not want to bore you with the details of such supports as the report from the various Chapters and Sets will indicate the level of support all in the spirit of brotherhood and in tandem with our motto "Pro Unitate". However, it will suffice to state that social distancing has posed a lot of challenges in the running of the association as most activities that develop bonding, networking and, sharing of memories have been scaled down and the zoom and other social media platforms could not provide physical interaction. Despite these challenges, it is necessary to commend the various Chapters and Sets for their great efforts in keeping the association alive since the inception of the Pandemic. The current state of insecurity has not spared the association as members are seriously restricted in their movements across the country which would have improved the level of interaction among members of the association.

4. It is to be stated that on receipt of the mandate of leadership of this great association on 14<sup>th</sup> March 2020, the National EXCO commenced work immediately by holding a meeting within minutes and thereafter several meetings have been held on the zoom platform due to wide dispersal of its members across the 4 chapters; i.e., Lagos, Ilorin, Abuja, and Port Harcourt. Furthermore, a lot of interactions were sustained using the Set Reps platform. It will be necessary to state that our association has remained a key player in the financial commitments to USOSA and the association participated actively in the USOSA plenary held in December 2022 at Abuja. Presently we have activated the USOSA empowerment and networking platform in Ilorin and encourage our members to be actively involved in all USOSA activities. The constitution of the association has undergone several reviews and a draft of the reviewed constitution was presented by the previous EXCO. This draft has also undergone several reviews leading to the final draft that will be presented during this AGM for further necessary considerations and adoption. The importance of a constitution to an organization such as ours need not be overemphasized as it is the life of the association. Also, it is necessary to state that two new Chapters have been inaugurated i.e., Ibadan and



UK Chapter, I hereby thank the member of the two Chapters for activating the chapters that are helping to make the association more vibrant. It is solicited that more chapters be established in other locations both within and outside the country. Further to decisions taken during the 2021 AGM, a committee was set up under the chairmanship of Mr. Femi Edun (1983 Set) to drive all activities relating to the 50th anniversary of our Alma Mater. It is worthy to note that the committee has done a tremendous job. This AGM and other previous activities over the last 8 days attest to the volume of sacrifice by the committee and Ilorin chapter. I hereby appeal to all members of the association to render maximum support to the committee to enable it conclude its mandate. Also, I appeal to all members to please ensure that they participate actively in the programme of events to mark our 50th anniversary.

- 5. It is my conviction that this is notthe period to reel out achievements as the task of moving the association forward is a collective task for all members. While commendation is being given to members who are financially up to date at the various Chapters and Set, it is important to state that the level of financial support to the association in form of dues is generally low. The details of such support will be presented by Treasurer/ Financial Secretary during this AGM. However, it is to be stated that dues alone are not enough to achieve the association's financial sustainability so as to enable it to achieve the desired impact on the lives of the members and our Alma Mater. There is the need to develop financial models to effectively fund the association.
- 6. It is worthy to state that our association, though being a member of USOSA cannot afford to shy away from being a leading advocacy group in the country. We can leverage and seek government support for the association on behalf of our Alma Mater using contacts within our association occupying strategic appointments both in the public and private sectors. These efforts will ensure that our association will become more viable and sustainable thereby improving the welfare of our members and growth of our Alma Mater. Furthermore, necessary discussions will be held during this AGM on the viability and sustainability of welfare programs such as life and health

insurance programs for our dear members of this association.

Finally, as I end my address, Ithank you all for your presence at this AGM. I must express my sincere appreciation to the Chairman and Members of the Board of Trustees, members of the national EXCO committee, Chairman/ Chairperson and members of the various Chapters' executive committees, our dear members in Diaspora, the various Set Reps for their support and guidance in the activities of the various Sets and indeed all members of the association for their support to the association at all times. My sincere appreciation goes to the Chairman and Members of the Local Organizing Committee constituted by the Ilorin Chapter for their efforts in organizing this AGM despite the constraints posed by the prevailing security challenges being experienced across the country. I hereby commiserate with all members of the association who lost their family members, friends and associates, especially during the period of this pandemic May Almighty God grant succour to us all. Please let us all stay safe and participate actively in the forthcoming

general elections by carrying out our civic towards electing responsible and credible leaders across all strata of Leadership i n o u r country. Thanks and God bless us all.

# ILORIN CHAPTER HOSTS JUSTICE ATOKI, FIRST HEAD GIRL - VISITS SCHOOL

he Kwara State Ministry of Justice played host on behalf of the State Government to the delegates from the Community Court of Justice, ECOWAS, led by the Vice President of the Court, Honourable Justice Gberi-be Outtara, for a week-long sensitization mission to my State. The sensitization programme was the kind done in Countries, but due to the size of Nigeria, they had to break down the sensitization for better impact. The programme was very successful and well attended.

At the opening ceremony of the sensitization mission, chaired by the Deputy Governor of the State, delivering the remarks on behalf of the President of the ECOWAS Court, was Hon. Justice Dupe Atoki, the only Nigerian on the committee of Judges. She started the remarks by introducing herself and shortly after mentioned how returning to Ilorin was a homecoming for her, having attended FGC Ilorin and also privileged to have been the first head girl of the School. I didn't know when I started clapping for her and started chatting with 2 of my schoolmates, who were also in attendance, both Magistrates of the Kwara State Judiciary.

Shortly after the conclusion of the opening ceremony, I approached Justice Dupe Atoki together with the two schoolmates, something I ordinarily wouldn't do. She was particularly happy to identify with us and shared some memories with us, she thereafter invited us to join her on her planned visit to the School after the Mission, later in the week. It was as if she met family, she couldn't hide her affection for the

school where she made history before going ahead to become one of the most prominent female figures in the continent.

On Friday, the 25th February 2022, we linked up with Hon. Justice Atoki for her proposed visit to our school, FGCI. I shared the ride with her while other members of the formidable delegate including the Chairperson of the Ilorin alumni of the School Dr Banke Balogun, Dr Dipo Akanbi, a former Chairman of alumni and Zainab Usman led in their vehicle. I heard from Justice Atoki, that the temporary site of the school was the present day College of Education, Ilorin. She had a faint memory of the only busy road in Ilorin then, Taiwo road. Is it still the busiest road in Ilorin? Definitely one of them. She left the school in 1974, where was I in 1974? My parents most likely haven't even met themselves then even though they came from the same village.

Justice Atoki was well received by the management of the school, the joy on her face was surreal. She was elated and couldn't hide it, it was her first time in the new site of the school and the first time on FGCI soil since she graduated. While being hosted in the office of the Principal, some prefects of the school joined us and when Justice Atoki was introduced as the first head girl of the school, the present head girl almost froze, if she could be an ancestral senior for me, then she is a historic-senior for her, something that probably would've only been read in books or seen on the rolls of honour. The present head girl was given birth to in 2007, the same year I left the school. Now I feel old already too.

It was my fourth time entering the Principal's office since I graduated, but each time I entered, I always

remember what brings one to the Principal's office as a student then. It was either for the conferment of prefect-ship or for the collection of suspension/expulsion letters or punishments of some sort. I had to make a joke of it at the office, I was a very good, obedient and disciplined student in school.

In the words of encouragement from Justice Dupe Atoki (I think there's a thing with the name of successful people, it's always simple kinda, I should consider making my name simpler and shorter too), it is important for one to channel his/her energy early enough in life for good. She was made the Head Girl of the school, at a time when she was perhaps the youngest in the class and with no prior experience in leadership or position of responsibility. She would go on to make many other firsts and achieve so much in her chosen career, including being the first female to head an organ of the African Union. She said when challenges come as they would, try to climb over them, if you fail, try digging deep, if you fail, try to run around it and if you fail at that, blast the challenges with all you can, we shouldn't romance our problems and challenges and watch them kill us. You are never too young or too old to pursue your goals and keep developing yourselves. She spoke passionately to us and the students before praying wholeheartedly for the students.

I saw the student in Justice Atoki again, as she took pictures with the school Principal officers, students and delegates. For her, the visit was as important as the sensitization mission itself, she sure would love to return for the 50th anniversary next year with what she saw. I was also impressed with the look the school was carrying with interlocking tiles around our assembly hall.

# MINUTES OF MEETING OF THE 11TH AGM/REUNION OF FGCIOSA HELD ON 25-26FEBRUARY, 2022 AT PORT HARCOURT

This document will, in addition to the minutes of the AGM, incorporate some important updates regarding the general activities and events that took place 25 - 26 February, 2022 at Port Harcourt. These updates would be on the Meet & Greet evening and the guided tour of the city.

#### 1. COMMENCEMENT

The 2022 AGM of the association was a two-day event which kicked off in earnest on 25<sup>th</sup> February, 2022 marking the first leg of activities lined up for the annual gathering. This first gathering was the Meet & Greet (M&G) in line with the general program of the event. The venue for the M&G was Don's Suites, 67a Woji Road, GRA Phase II, Port Harcourt, and kick off time was 4pm.

The M&G was attended by many of our members most of whom came from outside PH. The MGM was a rewarding moment for attendees most of whom were meeting for the very first time after a long time. It was such a great time to bond, relate, exchange banters and reminisce shared school days' memories.

The evening event also had slots for general introduction, a segment that saw each member, from some pioneer/older sets interacting with the very young sets in attendancetaking the floor to introduce themselves. It also offered the LOC the time to sell to members the event's commemorative items (2d/3d T-shirts, Sash) produced by the host Branch at some token rates. On the whole, the general atmosphere was warm and friendly, with rich entertainments and a variety of musical genres carefully synced by the DJ for the dancing and listening pleasure of everyone. The success of the evening plus the absence of any hitches was a confirmation of the LOC's and the event's adherence to strict Covid19 protocols and adequate logistics and security arrangements for the attendees. At the end, the M&G proved a welcome prelude to the next day's event, the AGM proper.

#### 2. THE AGM PROPER

This took place on 26<sup>th</sup> February, 2022. Based on the approved program, it was observed in two modes, the outdoor mode, and the indoor mode. The outdoor mode is always a deliberate inclusion in the program of event. It offers our members, especially guests from outside the hosting city/state the opportunity of sightseeing and visitations to places of interest, special monuments and historical sites where possible. This is what makes the AGM unique as an all-embracing exposure and engagement for participants.

#### I. The Outdoor Event

The outdoor event of the 2022 AGM preceded the indoor engagement that day. It took place between 9am and 11am. There was a free transport for participating attendees to a government recreational facility, The Pleasure Park for sightseeing and unwinding. It was an exciting experience as members engaged in some mild sports, boat rides and other fanfare varieties. It will be recalled that some members of the Host Branch who came in their private vehicles later joined the group at the park for a feel of the treats. This session came to a close with a light refreshment at the Park's restaurant to complement the wonderful experience for everyone that participated.

#### ii. The Indoor Event

There were two sessions of this segment. The afternoon session which started by 12:30pm featured full deliberations, report presentation etc on one hand, and the AGM dinner on the other. The meeting adopted a hybrid approach with both physical and virtual engagements going on simultaneously. For effective time management of the event, the order of protocol was established by the MC, Mr. Ekene (92 set) as follows:



- -The Chair and members of the BOT present
- The National President and Exco members present
- The LOC Chair and members present
- Members of the senior sets of the FGCI family present
- Members of the younger sets of the FGCI family present
- Invited guests and distinguished ladies and gentlemen

With the protocol in place, every other member was to speak on the floor by adopting the order as established.

To finally kick off proceedings under this session, the National Anthem was rendered followed by an opening prayer which the second stanza of the National Anthem subsisted in recognition of the diverse religious backgrounds of our members. Thereafter, members took turns to introduce themselves to the meeting. It included those participating physically and virtually. Introduction was allowed to be as revealing as possible, giving name, set year, house, current professional/vocational engagements, service status (active, retired or still searching) etc.

#### Welcome Address

This was presented by Mrs. Maeve Ere-Bestman, the National VP of the association. She used the opportunity to welcome everyone to the 11<sup>th</sup> AGM/Reunion of the

group. She reminded the meeting that the event's program was carefully chosen to enable us address the critical issues that confront us as an association. She enjoined all to contribute actively to very robust and meaningful deliberations that would yield the desired outcomes. She also told the audience to prepare for a relaxing evening after the afternoon session with a multicourse dinner, drinks, soft music and comedy. She finally thanked all for coming, encouraging those who couldn't make it to begin in time to prepare for the twelfth edition which the Host Branch would be announced in the course of the meeting. Finally, she used the opportunity of her addressto thank Dr. Obele (78 set) on behalf of all for providing a dedicated medical stand comprising medical personnel, ambulance and medicine to support the day's event.

#### **The President's Opening Address**

Before giving his speech, the President called for a minute silence in honour of our departed members within the intervening period. This was accordingly observed. The President then welcomed everyone participating both physically and virtually to the 11<sup>th</sup> edition of the association's AGM/Reunion. He recalled how the current national EXCO swung into action by conducting their maiden meeting few minutes of being inaugurated on 14<sup>th</sup> March, 2020. This, according to him was to underscore the pace and energy the new EXCO was going to use to deliver on the mandate. He also told the meeting that barely two weeks into their tenure, a major existential threat, the Covid-19 pandemic hit the entire globe leading to far-reaching lockdowns by so many countries including Nigeria. He reflected on the setbacks this development brought about in running the association including the forced delay in the conduct of the 2021 AGM in June that year against the, hitherto, sacrosanct month of February each year. He also recalled other challenges the association faced as a result of the pandemic when the various Sets and Chapters were preoccupied with providing palliatives and supports to some members of the subgroups on need basis. He appreciated those Sets and Chapters that have consistently met their financial obligations to the association even during the pandemic.

Giving further details, the President told the meeting that our association has maintained a very active role in USOSA with clean financial records till date. He informed the gathering that the association featured actively at the USOSA plenary in December, 2021 held at Abuja. He also confirmed the activation of the USOSA Empowerment and Networking platform in Ilorin.

#### Minutes of 11th AGM in Port Harcourt

In the absence of the National Secretary, the minutes of the last AGM was presented by the Assistant National Secretary, Abdulhakeem Abdulkadir. Members were directed to the brochure for details of the minutes while copies were also projected on the screen for the benefit of those joining virtually. Motion for adoption of the minutes and a look at matters arising therefrom were deferred till the presentation of the financial report and other associated updates.

#### Financial Report

This was given by the National Treasurer. Again, attendees were directed to the brochure for details while a soft copy was displayed online for virtual participants. The report was presented under key subheadings as follows: corporate information, Director's report, Independent Auditor's report, Statements on financial position, profit and loss, cash flow and changes in equity. In another vein, a review of the existing template for Set contributions with proposed adjustments was presented by the National Financial Secretary of the association. The need for the proposed amendment was to reflect the reality of the expected decline in the earning power of some members of the older Sets, the enhanced income of the middle level and younger Sets amongst other key considerations. A breakdown of the three templates as presented and tagged, Annex A.

With the minutes and reports thus presented, a motion for adoption was moved by Engr. Ifeanyi Ukachu (1980 set) and seconded by Mr. Dumoyo O. (2009 set).

#### Mtters Arising

On matters arising, the President took the meeting through the key decisions and action points reached at the last AGM. He briefed the meeting on each of such decisions, with updates on those closed out and the work in progress. Full deliberations on matters arising and other agenda items went thus.

#### **Attendance and Online Participation**

The President pleaded that online participants should provide adequate information about themselves in the chat box for comprehensive capture and compilation of the attendance list. He recalled the haphazard nature this issue was handled at the last AGM which made it impossible for us to have a complete and reliable attendance list. It is worthy to note that due to the aforementioned, no attendance list attached to this report.

## 50<sup>th</sup> Anniversary Central Planning Committee

The President confirmed that the committee to plan and steer preparations for the 50th anniversary of the



gender sensitivity leaning. He maintained that the committee has the latitude to co-optmore members, and volunteers are also welcome where they can contribute useful ideas to progress the work of the committee. Above all, he reminded all that planning for the 50<sup>th</sup> anniversary was not restricted to the committee and volunteers but rather a collective responsibility of all members of the association. He therefore solicited for our concerted efforts and full cooperation to drive the planning phase and other follow up commitments.

#### The Constitution

The President told the meeting that the current Exco inherited a constitution that was already undergoing some amendments. He confirmed to the meeting that Exco has concluded the amendment and would be presenting a final draft in the course of the meeting. He shared the extensive process, including some legal reviews and inputs adopted to produce the final draft. He drew attention to the fact that no constitution is an absolute reference for any organization, but rather a reasonable guide for the effective running of the organization. According to him, constitutional amendment is therefore a continuous process necessitated when new ideas and concerns for an association become important subjects for consideration. He elaborated more that the last pandemic brought about a new normal which made the virtual option imperative for organizations in conduct of meetings and other engagements. The need for us to reflect and input such new developments as important constitutional matters can therefore not be overemphasized, he concluded.

Important Sensitization of the School Management on Safety and Security The President confirmed to the meeting that the planned visit and sensitization of the management of the school on the critical areas of safety and security in the face of current realities in the society have been carried out. He used the opportunity to thank the Ilorin Chapter for maintaining close contacts and interactions with the school. He revealed that the Ilorin Chapter visited the school on important engagements 48hrs to the commencement of the AGM. He told the meeting how happy and elated the principal of the school has always been because of the continuing support of the association in such diverse key areas in the school, including, mentorship, infrastructure, guidance and counselling etc. The President called for more interventions in like manner as current efforts, although quite commendable would not be said to be exhaustive. He said, that way, the obvious yawning gaps in the critical areas of need for the school will further be bridged. He added that the forthcoming 50<sup>th</sup> anniversary of the school offers a good opportunity for more support. He pointed out that interventions under the 50<sup>th</sup> anniversary would be harmonized by the planning committee to eliminate potential project duplication.

Still under matters arising, Dr. PrincewillObele referred to the proposed templates for Set dues stating that a review has become necessary as the previous template was ambiguous and lopsided. He also made case for a budgetary provision for the activities of the Exco. According to him, the budget for the Exco could be sustained through contributions by the Chapters and Sets fixed to such a minimum amount that would not constitute double taxation. He went further to say that the current notion that the association only rallies funds for AGM should be corrected, insisting that it has never been so. He said that with the constant paucity of funds faced by the association, expanding activities to other areas of interest for members is obviously an uphill task for the Exco. He advised that fundraising should be treated as a continuous and multidimensional procedure where strategic contacts with distinguished Alumni, governments and companies should be explored. Contributing under matters arising, the BOT Chair, Mr. Tony Osunlaja said that the primary responsibility of raising funds for the association lies on the portfolio holders, that is, the Financial Secretary and Treasurer of the association and its sub units. He mentioned that contrary to the logic of reducing the amount for the annual contribution of the Sets, his '77 Set has found a way around by ensuring they regularly pay their annual dues. He therefore advised we could leave the old template to drive the contributions at the Set level. He opined that Sets could meet their financial obligations to the association based on a revised lower template which could pay from the higher contributions based on the old template. Contributing, Engr. Ukachu I. wanted the Sets that have been compliant and successful in meeting their financial obligation to the association to share the secret of their consistency. Mrs Maeve

dues. She said they have a dedicated account into which they pay a certain amount per head without waiting till the end of the year. Some members of her Set are specifically mandated to drive the process through constant reminders to the members to pay into the purse. At this point, time was yielded to those online to make their contributions. Babaita A. (2006 Set) contributing, said his 2006 Set has been occupied with contributions for their members' welfare. He however added that they are now ready to focus on discharging their constitutional duty including meeting their financial obligations to the association. He also requested that if the Set could get the list of projects earmarked by the national body for the school, they would be ready to embark on any of the projects. More so, doing it that way, he reasoned, would help eliminate the possibility of duplication in project executions amongst the Sets, the national body and CPC. Yetunde O. an online contributor said her Set sustains regular engagements with members, especially during members' anniversaries like wedding, birthdays etc. She also harped on transparency in managing the finances of the association by carrying everyone along and sustaining the trust and confidence of members in the management and leadership of the association.

In a similar vein, the President told the meeting that most of our members hardly follow up important information including necessary financial updates disseminated through the various platforms, most members hardly read those updates he stressed. He recalled an example when Exco sent out information on various platforms for inputs to constitute the CPC for 50<sup>th</sup> anniversary, there was hardly any feedback from the platforms. On the Set Reps platform, they would read it but usually fail to cascade to their respective Sets to inform and elicit necessary feedbacks as appropriate. According to him, it was because of this kind of challenge his Set ('78 set) created two platforms. One strictly for the association's matters and the other for contents unrelated to matters involving the association.

#### Final Decision on Template for Set Annual Dues

At this point, the meeting took a further review of the proposed templates for the Set annual dues so as to decide on the template to adopt. In his contribution, the BOT Chairman, Osunlaja frowned at the misinformation that funds are raised only for AGM. First, he told them that AGM is a constitutional commitment the association must comply with annually. Again, he reminded the meeting that less than 25% of the Sets are up-to-date with their statutory payments, and therefore most of them criticize the management of the association just to create basis to continuously renege on their statutory responsibility to the association. He said that the current Exco has demonstrated transparency and accountability in handling the association's resources. He referred to the financial report just presented, details which showed that the Exco spent only 100k in over a year now leaving over 6m in the association's coffers. He concluded by saying that the meeting should look at the proposed options - Annex B & Annex C, and decide which one to adopt. Immediately, a vote count was done and the result was thus, Annex B-24 votes & Annex C-5 votes. The President at this point declared Annex B as the duly adopted Template for the association. He added that the template is subject to further review if in future there are significant changes in the factors and indices considered in arriving at the current template.

#### Brief On 50th Anniversary Preparations by the Chairman of the CPC

At this point, the President called for a brief from the CPC Chair, Mr. Femi Edun, who was participating virtually on the 50<sup>th</sup> anniversary preparations so far. In his contribution, Mr. Femi Edunconfirmed that the committee as constituted comprised of members from 1982 -2014 Sets. He also said that they have been meeting regularly to put groundwork in place. According to him, they have also had extensive consultations with several of our elders, who ably are the pillars of the association. He revealed that they have already constituted five sub committees to drive the preparations. These subcommittees included:

Contact & Mobilization-headed by Yetunde O (83 set)

Events & Projects-headed by Wole O. (86 set)

Logistics & Security-headed by Usman A. (85 set)

Communication & Publicity-headed by Ejike U (99 set)

Finance Subcommittee-temporarily under the purvey of the CPC chairman himself, Femi Edun.



He added that they have co-opted into the CPC, Chapter chairpersons in both Nigeria and the UK. According to him, the work of the committee was still at the preliminary stage at the time with key focus on budgetary proposals to be drafted as soon as enough details were garnered on the projects and other features of the event. But from consultations with the school and information from other important sources as an important step, the committee has been able to compile a preliminary list of 29 broad project areas for the school.

The breakdown of these project areas was presented thus:

Provision of laboratory stools

Provision of plates, cups and utensils for the dining hall

Refrigerators for the laboratory

Plastic chairs for the college hall

Office furniture for staff

Renovation of classrooms, Exam halls

Modern gadgets and furniture for laboratory

Repair or replacement of current college generator

Renovation of the staff quarters

Land scaping

Burglar-proofing and security gadgets in the libraries

Sporting equipment

Computers, printers and scanners

Permanent tracks for sports complex

Solar lighting

Science equipment

Drawing boards

School bus

Solar CCTV

Rehabilitation of roads, drainage and erosion control

Fish pond and Orchard fencing rehabilitation

Oil Palm lining of school plantation

Cattle Ranch rehabilitation etc.

In the final selection and consideration of projects for the school, the CPC Chairman said the committee would be guided by project sustainability with very minimal maintenance challenges and non duplication of projects with those funded by the government for Unity schools. He also said that only projects with completion timeline within the available preparatory space at our disposal would be undertaken. Such projects, according to him would be impactful and target the important needs of the school no matter how small. Speaking further, he said that project intervention would go beyond physical infrastructure to extend the cue to:

- -Training for teachers
- Endowment and recognition for students
- Mentorship etc.

According to the CPC, the success and completion of these projects would be anchored on strong coordination between the association and the school. Furthermore, Chapters and Sets are expected to deliver commemorative projects for the 50<sup>th</sup> anniversary. The Contract and Mobilization subcommittee has the responsibility to coordinate Set and Chapter involvement in project execution and delivery.

In the area of fundraising, the CPC would be reaching out to Sets, Chapters and individuals. In addition,



the committee would also be reaching out to organizations that the association is connected with either because Alumni are owners or managers of such organizations. Some organizations and distinguished Alumni would also be reached to either adopt a project or contribute to what we are doing through sponsorship. Important government functionaries, especially some Alumni in positions of influence and authority would be approached for support. To incentivize these commitments, CPC created what he termed tears of sponsorship ranging from Bronze, Platinum to the highest. The CPC Chairman went further to say that they would set the benchmarks for these categories when drawing up the budget. According to him, the overall strategy is to attract individual and corporate sponsorship. The CPC Chairman remarked that the ways and means of hitting the marks would be through a full deployment of technology, sustained sensitization and campaigns using the various social media platforms amongst others.

The CPC was also planning to issue brief documentaries in their overall package. This would include interviews with the pioneer Principal of the school, Mr. Bola Olaniyan with other old Principals and teachers who are still around with us. There would also be documentary with the current management of the school and old students. The documentaries would amongst other things relay the interviewees' experience as what the school means to them, how it has shaped them for the careers and journey in life.

The President at this point thanked the CPC Chairman and his team for great efforts and well detailed presentation. He gave assurance that the EXCO, BOT and the association would cooperate and support them to ensure that they successfully deliver on this mandate. At this juncture, the MC announced a ten minutes break in line with the program of the day. On resumption from the break, the floor was yielded to an insurance expert invited to give a brief on relevant insurance schemes members can sign into. The VP introduced this segment, saying it became necessary as part of the general quest of Exco to provide sustainable and accessible welfare packages for our members. She said available records show that most of our members do not have any form of insurance cover. Regrettably, she lamented, many of our members have died or suffered disability either due to natural causes or accidents. She observed such unfortunate mishaps have placed supporting families or groups to such victims under severe hardships and financial burdens. According to her, it was on this score, and after due consultations with relevant industry stakeholders that Exco invited an insurance company to the AGM to give few minutes talk on insurance with a pointer to relevant policies for our members. She expressed the Exco's hope that this important engagement would educate members on the issue of insurance and enable them access the inherent benefits. At this point, an insurance representative from Stanbic IBTC Insurance Brokers took the stage to give a presentation. The insurance Rep. gave a summary of available policies of interest to include personal life and group life policies. She invited our members to take advantage of the services and enroll as appropriate.

#### **Election of National EXCO Officers**

The President told the meeting that the tenure of the current Exco would be terminating in few weeks' time, precisely, on the 14<sup>th</sup> March, 2022. He reasoned that as the meeting was the last official window for election of national officers, the need to conduct same had become very apparent. He then said that for the election to commence, the current Exco would step down for the meeting to proceed with the exercise. It was also announced that the BOT members present would conduct the new election. At this point, the BOT Chair, Mr. Osunlajaassumed the official role of the Chief Returning Officer, CRO following the vacation of the

various offices by the former Exco as earlier directed. Observing that he was the only BOT member attending the meeting, the CRO exercised the discretionary powers of the assignment by appointing Mr. Ayo Joseph to assist him. To kick off the election, the CRO reeled out the official guidelines for the conduct of the election. The key elements of the guidelines were:

- No voting by proxy
- Fair and transparent voting process must be guaranteed
- Voting shall be through an electoral college only



- National Exco and BOT members shall beautomatic delegates
- Nomination shall be by way of raising of hands
- For the purpose of courtesy, a nominee is expected to accept the nomination
- Self-nomination is allowed
- Vote counts to be conducted and results announced immediately At this point, the CRO requested for the list of members of the electoral college from each of the four Chapters-PH, Abuja, Ilorin and Lagos. Each electoral college was made up three members only.

Available positions to be vied for included:

- The President
- Vice President
- General Secretary
- -Assistant General Secretary
- Financial Secretary
- Treasurer
- -PRO
- Welfare Officer

The nominations and voting for candidates proceeded as follows:

Two Ex-officio Members

According to the CRO, the constitution provides that the Ex-officio position can only be filled by a member of the old Exco. But as observed, none of

them was around and to that extent, their nomination and inclusion in the new Exco were deferred to the new Exco to handle.

#### Oath taking by the New Exco

The CRO at this point called out the newly elected national Exco members for formal inauguration. He requested Mr. Ayo Joseph to swear in the new Exco. The oathtaking was administered by Mr. Ayo Joseph in the style and approach of a distinguished legal luminary to the joy and applause of all in attendance, physically and virtually. Sir. Chucks Anigbogu and many others who joined virtually were captured showing rapt attention all through the electoral process and equally applauding the final outcome. The election came to an end with the oathtaking by the new Exco as administered Mr. Ayo Joseph. The composition of the new Exco could be described as a return of the "old soldiers" with the re-election of about 90% of the former members, including the President. The new Exco at this point, went back to their former seats at the high table to complete the rest of the program of the day under a renewed mandate.

#### **2023 AGM**

The next item at this point was setting the pace and tone for the next AGM. The President noted that this was very straightforward as it has already been agreed that next AGM would be hosted by the Ilorin Chapter. He said the final task of the meeting was to formally ratify the choice of Ilorin Chapter as the Host for the 2023 AGM, and by the city's rights as the traditional citadel of our school, the 50<sup>th</sup> anniversary would also be held in Ilorin.

#### **AOB**

Mr. Ayo Joseph brought forth two important issues. First, he observed the curious prevalence of the problems of cultism, ritual killings, sexual abuse and predations especially among the youths. He said



the urgency is now for the association through the Exco to engage the school management and the students with a view to bringing these issues to the fore and dissuading them from being part or victim of the wave of evil in the society. In his second contribution, Mr. Ayo Joseph said that a lot of the infrastructural projects going on in the school were being driven by current Head of Service of the Federation who is an Alumni of the 1979 Set. He wanted to know if Exco had found time to pay an official visit to her, and if not consider doing so as soon as is practicable. He also reasoned that such a visit could provide the needed latitude to put forth more request for assistance and support in the school. In his own contribution, Mr. Gambari advised the association to try and reach out to many of the Alumni who have distinguished themselves in various fields of endeavour. He recalled a former governor who is an Alumni and to whom many of us who had the opportunity supported his aspiration for the high office of the governor of his State. He maintained the association is blessed with a lot of such Alumni, including the retired Army Generals and other very senior officers in the military, paramilitary, State and Federal governments etc. In his own contribution, the BOT Chair made a special mention of Mr. Gambari whom he eulogized as a highly respected iconic traditional and royal figure in Ilorin. In the same vein, Mr. Osunlaja poured out encomiums on Snr. Ruby Nakpodia, the first deputy Head girl of the school. He remarked that Snr. Ruby has been most passionate and supportive to the association. He disclosed that she has attended all the association's gatherings from inception. He thanked her for being such a longstanding role model and inspiration for both the leadership and members of the association.

In another vein, Mr. Osunlaja canvassed that the association of our dream should be the one that members attend meetings and official events as fixed from time to time. He also told the meeting that we needed to reinvigorate the Chapters, renew commitment to meeting our constitutional obligation to the association. He agreed that the AGM is the most prominent thing we do as an association yearly, but that is according to the constitution of the association. He stated that if the association receives more money and support from members, more programs would certainly come on stream for the association and its members.

He reminded the meeting that from inception, the association has been delivering one intervention or the other to the school. This according to him started long before sets began to sponsor projects there, especially as a commemoration for their anniversaries. He therefore advised that we should disabuse our minds that AGM is the only event we handle as an association. He called for more Branches to be created. He welcomed the Ibadan and UK Branches for coming on stream, while also noting that Jos Branch coming on stream was very imminent.

#### Closing Remarks - BOT Chairman

The BOT Chairman, Mr. Tony Osunlaja thanked all those who came from distant places like Lagos, Abuja, Ilorin etc by air or by road. He appreciated the enormous sacrifice in making these long journeys from the standpoint of cost and security concerns. He appreciated the Exco and all those who made contributions in making the event the success it has become. He reminded all about the ongoing preparations for the 50<sup>th</sup> anniversary next year and called on members to support the Exco in this regard. He formally invited all to the 50<sup>th</sup> anniversary celebrations which he described as the biggest event ever for the school.

#### Vote of Thanks - LOC Chairman

The LOC Chairman, Engr. Ifeanyi Ukachu thanked all participants on both physical and virtual platforms for honouring the event. He also thanked the association for entrusting the hosting rights for the AGM to PH Chapter back-to-back, 2021 &2022 editions. He pledged to continue to give his best to the association with his new election and mandate as the national secretary of the association. At this point, he told the meeting that dinner would hold immediately in the same hall, but pleaded for few minutes for the rearrangement of the chairs and tables to create the right ambience for the dinner session.
